This open call exhibition is a great opportunity for new and existing artist members, many of whom will be showing at DAM for the first time. Artists are encouraged to give varying interpretations of cycling in Detroit through 2-D and 3-D works. As a fun option, DAM will provide a bin of bike parts at the gallery, and we invite you to choose components to use in your unique creations. Retail price for each object must not exceed \$500, and DAM will cap the amount of entries due to gallery space restrictions. A current DAM Artist Membership is required to participate. So what are you waiting for? Get the wheels turning and start cranking on your masterpiece!

THE DETROIT ARTISTS MARKET (DAM) IS A NON-PROFIT INCORPORATED ORGANIZATION. IT'S PURPOSE IS TO SERVE THE DETROIT ARTS COMMUNITY BY EXHIBITING AND PROMOTING THE WORK OF EMERGING AND ESTABLISHED DETROIT AND MICHIGAN ARTISTS, AS WELL AS NATIONAL AND INTERNATIONAL ARTISTS. IN FULFILLING A COMPONENT OF THIS MISSION, DAM DEVOTES RESOURCES TO PROVIDE AN ARTIST SALES SUPPORT FACILITY WHERE ARTWORK MAY BE EXHIBITED AND SOLD. THE TERMS AND CONDITIONS OF EXHIBITION AND SALES ARE AS FOLLOWS:

Title. The Owner warrants that the Owner has created, and has unencumbered title to, all art objects consigned hereunder.

Receipt. DAM receives the art objects solely for the purpose of examining them at its earliest convenience and deciding whether they will be offered for sale by it.

Return of Art Objects. Art objects submitted for exhibition and sale will, if rejected, be picked up by the Owner within two weeks after notice to that effect. Once work has been accepted it cannot be removed for the duration of the exhibition. Art objects which are accepted and not sold will be picked up within thirty days after the end of the exhibition. If art objects are not picked up by the thirty-first day of July following the date of receipt, DAM reserves the right to dispose of them, and if they are sold to retain the proceeds.

Records. DAM shall keep proper records of transaction regarding the Owner's work, and such records shall be available for the Owner's inspection during regular business hours.

Reproduction Rights. The Owner reserves all rights of reproduction of consigned work, provided DAM may publish photographs of all such work for promotional and/or educational purposes as it may deem appropriate.

Liability. DAM is acting solely as a representative of the Owner, and neither it nor its members shall be liable for loss or damage to works of art on the premises (or exhibited elsewhere within the sole discretion and under the control of DAM) due to fire, theft, negligence or any other cause. DAM may at its option maintain such insurance coverage as it deems appropriate, but it shall have no obligation to do so.

Sales Prices. Prices for art objects consigned hereunder are set as forth on the reverse side hereof.

Commission. DAM shall receive a commission of 1/3 (33.33%) of the sales price, regardless of other gallery affiliation.

Payment. Payment on all sales shall be made to the Owner within thirty days after the end of the month in which the proceeds of the sale are received. Payments to Owner for works sold on DAM Installment Sales Plan shall be made no later than thirty days after work is paid in full.

Binding Effect; Modification. The rights and obligations of DAM and the Owner shall be binding to the benefit of their respective heirs, representatives, successors and assigns. Any change in this agreement must be in writing.
