

2024 Scholarship Application & Call for Entry Procedures

College for Creative Studies Scholarship Awards & Exhibition

March 8 – April 6, 2024

The **Detroit Artists Market** (DAM) is pleased to host the 2024 Scholarship Awards and Exhibition. This year's scholarship and exhibition will commemorate and celebrate the diversity and achievements of College for Creative Studies (CCS).

Eligibility:

DAM would like to invite all currently enrolled CCS students from all departments, including but not limited to Animation, Art Education, Communication Design, Concept Design, Fashion Design, Film, Game Design, Illustration, Interdisciplinary Art & Design, Interior Design, Photography, Studio Art & Craft to apply for the John F. Korachis Annual Scholarship Awards and Exhibition. All scholarship finalists will be invited to exhibit their juried work, along with select CCS alumni and faculty at the DAM during this year's Annual Scholarship Awards & Exhibition. Three scholarships will be awarded to select students exhibiting masterful execution of concept, design and media expertise.

Entry Procedure:

All currently enrolled CCS second, third, fourth year and graduate students are encouraged to submit this call for entry along with images of their work and supporting documents to DAM commencing on **December 5th, 2023 through no later than January 13th, 2024.**

- Complete all parts of the application, 2024 Call for Entry Application Form
- You may submit up to 15 digital images representing the scope of your work.
 - Digital images are to be submitted through email. JPEG format files are preferred.
 - Keep files to a maximum of 1.5MB, please.
 - File names need to be as follows: Entry number, Name, Artwork Title
- Include a reference sheet with thumbnails of images, dimensions, medium and retail price of each submission.
- Submit an artist statement.

Application form, artist statement, images, and reference sheet will be submitted to DAM by email to Kelly Farrell, DAM Gallery Manager at kelly@detroitartistsmarket.org, no later than **January 2nd, 2024.**

Exhibition Requirements:

- Students must be currently enrolled at CCS.
- All work must be original; no substitutions or copies will be accepted from the original juried work.
- All work must be for sale.
- 2-D work must be mounted and/or framed with hanging mechanism and ready for installation.
- 3-D work must be delivered with all hardware and instructions necessary for installation.
- DAM reserves the right to disqualify work that does not meet the requirements listed above and/or gallery regulations.
- All student finalists are requested to participate in the Gallery Talk.

Jury Process

Images and supporting documents will be reviewed and juried by the Scholarship Committee. The committee will select participants and scholarship recipients based on each applicant's masterful execution of concept, design and media expertise.

Sales

DAM retains 1/3 (33.33%) commission. Michigan sales tax is collected and submitted. Payments to artists will be no later than 30 days after the closing of the exhibition.

Liability

DAM is acting solely as a representative of the owner, and neither its staff nor its trustees, officers, directors, employees, agents, representatives or members shall be liable for loss or damage to works of art on the premises or transit (or those works of art that may be exhibited elsewhere within the sole discretion and under the control of DAM) due to fire, theft, negligence or any other cause. DAM may at its option maintain such insurance coverage as it deems appropriate, but it shall have no obligation to do so.

Volunteer

Students are encouraged to volunteer at DAM. If you are interested in volunteering, please call the DAM at 313-832-8540.

Delivery and Pick-Up

All selected artwork must be delivered during the scheduled drop off dates by hand or by mail. All work must be picked up during scheduled pick up dates or if shipped, the appropriate shipping container and postage must be delivered to the DAM before the end of the exhibition. Artwork left after the scheduled pick up date will become property of the DAM.
